



Privacy Notice for Members, Trustees/Governors and Volunteers

Under data protection law, individuals have a right to be informed about how the academy uses any personal data that we hold about them. We comply with this right by providing 'privacy notices' (sometimes called 'fair processing notices') to individuals where we are processing their personal data.

This privacy notice explains how we collect, store and use personal data about members, trustees/governors and volunteers in the academy in line with the General Data Protection Regulation (GDPR) and the Data Protection Act 2018.

We, University Academy Keighley, are the 'data controller' for the purposes of data protection law. This means that we are responsible for deciding how we hold and use personal information about you.

The personal data we hold

We process data relating to those volunteering at University Academy Keighley. Personal data that we may collect, use, store and share (when appropriate) about you includes, but is not restricted to:

- ✓ Contact details
- ✓ References
- ✓ Evidence of qualifications
- ✓ Employment details
- ✓ Information regarding business and pecuniary interests

We may also collect, store and use information about you that falls into 'special categories' of more sensitive personal data. This may include information about (where applicable):

- ✓ Race, ethnicity, religious beliefs, sexual orientation and political opinions
- ✓ Disability and access requirements

Why we use this data

The purpose of processing this data is to support the trust to:

- ✓ Establish and maintain effective governance
- ✓ Meet statutory obligations for publishing and sharing trustees'/governors' details
- ✓ Facilitate safe recruitment as part of our safeguarding obligations towards students

- ✓ Undertake equalities monitoring
- ✓ Ensure that appropriate access arrangements can be provided for volunteers who require them
- ✓ Ensure receipt of information from the LA to facilitate the role of trustee/governor

Use of your personal information for marketing purposes

Where you have given us consent to do so, the trust may send you marketing information by email promoting trust events, campaigns, charitable causes or services that may be of interest to you. You can withdraw consent or 'opt out' of receiving these emails at any time by contacting the Data Protection Officer, as above.

Our lawful basis for using this data

We only collect and use personal information about you when the law allows us to. Most commonly, we use it where we need to:

- ✓ Comply with a legal obligation
- ✓ Carry out a task in the public interest

Less commonly, we may also use personal information about you when:

- ✓ You have given us consent to use it in a certain way
- ✓ We need to protect your vital interests (or someone else's interests)
- ✓ There is a legitimate interest to share the information

Where you have provided us with consent to use your data, you may withdraw this consent at any time. We will make this clear when requesting your consent, and explain how you go about withdrawing consent if you wish to do so. Some of the reasons listed above for collecting and using personal information about you overlap, and there may be several grounds which justify our use of your data.

Collecting this information

Whilst the majority of the information we collect from you is mandatory, there is some information which you can choose whether or not to provide to us. Whenever we seek to collect information from you, we make it clear whether you must provide this information (and if so, what the possible consequences are of not complying), or whether you have a choice.

How we store this data

Personal data is stored within the secure school network and is only used for purposes directly relevant to your work with the academy. When your relationship with the academy has ended, we will retain and dispose of your personal information in line with legislation current at the time. Please request further information, if required, from the Data Protection Officer, as above.

Data Sharing

We do not share information about you with any third party without your consent unless the law and our policies allow us to do so. Where it is legally required, or necessary (and it complies with data protection law) we may share personal information about you with:

- ✓ Government departments or agencies, to meet our legal obligations to share information about members/trustees/governors

- ✓ Our local authority, to meet any legal or statutory requirements
- ✓ Suppliers and service providers, to enable them to provide the service we have contracted them for, such as governor/trustee support
- ✓ Professional advisers and consultants, to comply with entitlements and assist with claims
- ✓ Employment and recruitment agencies, as necessary in the performance of contracts with them
- ✓ Police forces, courts and tribunals, in order to uphold law and order

Transferring data internationally

Where we transfer personal data to a country or territory outside the European Economic Area, we will do so in accordance with data protection law.

Your rights – how to access the personal information we hold about you

Individuals have a right to make a ‘subject access request’ to gain access to personal information that the trust holds about them. If you make a subject access request, and if we do hold information about you, we will:

- ✓ Give you a description of it
- ✓ Tell you why we are holding and processing it, and how long we will keep it for
- ✓ Explain where we obtained the information, if not from you
- ✓ Tell you who it has been, or will be, shared with
- ✓ Let you know whether any automated decision making is being applied to the data, and any consequences of this
- ✓ Give you a copy of the information in an intelligible form

You may also have a right for your personal information to be transmitted electronically to another organisation in certain circumstances. If you would like to make a request, please contact our Data Protection Officer.

Your other rights regarding your data

Under data protection law, individuals have certain rights regarding how their personal data is used and kept safe. You have the right to:

- ✓ Object to the use of your personal data if it would cause, or is causing, damage or distress
- ✓ Prevent your data being used to send direct marketing
- ✓ Object to the use of your personal data for decisions being taken by automated means (by a computer or machine, rather than a person)
- ✓ In certain circumstances, have inaccurate personal data corrected, deleted or destroyed or restrict processing
- ✓ Claim compensation for damages caused by a breach of the data protection regulations

To exercise any of these rights please contact our Data Protection Officer.

Complaints

We take any complaints regarding our collection and use of personal data very seriously. If you think that our collection or use of personal information is unfair, misleading or inappropriate, or have any other concern about our data processing, please raise this with us in the first instance by writing to our Data Protection Officer, as above.
